About the Seminar

“Social exclusion” is defined as the involuntary exclusion of individuals and groups from society’s political, economic and societal processes, which prevents their full participation in the society in which they live (UN, 2010). The Constitution of India envisages the right to equality irrespective of race, religion, caste, gender and prohibits all forms of exploitation of citizens of India. However, despite several constitutional provisions, policies, some sections in Indian society still remain socially excluded i.e the Scheduled Tribes (ST), Scheduled Castes (SC), differently abled, women in sex work and so on. Poverty is associated with socially perceived deprivation with respect to basic human needs. As per the 2011 Census of India, 31.5 percent of Schedule Castes were under below poverty line in rural areas (Panagariya & More, 2013). Further, the research studies carried out on the socially excluded sections have highlighted the need for special focus on such communities to realize the core principles of social equality and justice in the country.

Socially excluded in India constitute a significant portion of population. As per the 2011 Census, SC and ST population is 16.6 percent and 8.6 percent respectively. Similarly, the census data estimated that 2.21 percent of Indian population is suffering from one or the other kinds of disability. To cite a few, the census data 2011 highlighted that there are about 4.88 lakh transgenders in the country, where as the transgender activists estimated the actual population of transgenders would be around six to seven times more than the actual estimates, and manual scavengers around 7,94,000. According to the estimates of the women and child welfare department, there were about 3 million female sex workers in India and out of these, 35.7 percent of them were young girls below the age of 18 years. As per the annual report (2015-16) of National Aids Control Organization, the total number of People Living with HIV in India is estimated at 21.17 lakhs. Thus, all kinds of socially excluded communities put together constitute approximately 25 to 30 percent of Indian population.

Government, NGOs and Civil society organizations have been playing a significant role in addressing the inequalities through their target oriented and innovative interventions. While India targets to reach out towards the higher GDP growth and technological advancement, it is the need of the hour to look back to the reality and to create equal opportunities for the socially excluded sections in the country.

Social work as an academic discipline and practice-based profession promotes equity and justice where every individual gets an opportunity to live with dignity, develop and participate in various processes of the society. Social work profession with its humane approach evolved several strategies to work for inclusion of socially excluded

With this backdrop, the Department of Social Work, Andhra University, Visakhapatnam, under UGC-DSA Programme proposes to conduct a National Seminar to provide a platform to share the experiences of academicians, researchers and practitioners on different forms of exclusion and formulate inclusive programmes, so as to enable them to bring to the main stream of society. In this direction, the role of government, private sector and civil societies is onerous in partnering with different stakeholders for the development of vulnerable and marginalized sections.

Objectives of the Seminar

- To create a platform to academicians, researchers, administrators and practitioners to reflect on the social exclusion and its consequences
- To understand, analyse and document the experiences and role of social work practitioners and civil society organisations with respect to inclusion of excluded
- To come up with appropriate policy recommendations for better social inclusion processes in the society

- Policies, programmes and legislations related to social inclusion and their impact on socially excluded sections:
 - Scheduled Castes
 - Scheduled Tribes
 - Scavengers

 - Disabled - Physical (Locomotor, Visual, hearing etc.); Intellectual; etc
- Interventions and initiatives of Tri-sector on social inclusion

The author (s) should follow American Psychological Association (APA) format for references and other citations.
